Mr. McQuiston is a retired Captain in the Navy Judge Advocate General Corps, having served on active duty from 1980-1985 and as a Reservist from 1988 -2011. He served 4 years as Military Judge of Courts - Martial of the United State Armed Forces as his last assignment.

A *cum laude* graduate of Allegheny College and a 1980 graduate of the University of Pittsburgh School of Law, Mr. McQuiston is admitted to practice in all state and federal courts in Pennsylvania.
